Kent, Isaac Sr. & Wife to Lucinda Zumwalt Dec 25, 1835/ Aug 6, 1836 Deed Book A, pg. 410  
Know all men by these presents, that Isaac Kent Sr. and Lucy Kent, his wife, of the County of Warren and Sate of Missouri, have for and in consideration of the love and affection which we bear to our daughter Lucinda Zumwalt, wife of Saloman Zumwalt deceased and for the further consideration of the sum of one dollar to us in hand paid the receipt thereof we do hereby acknowledge, granted and conveyed unto Lucinda Zumwalt of the County and state aforesaid the following described tract or parcel of land to wit, situate in said County of Warren and being apart of the Northwest quarter of Section twenty two in Township forty seven Range Two west containing sixty acres and bounded as follows to wit, Beginning at the south east corner of twenty five acres by us deeded to Archibald Gipson at a post from which a burr oak...[the rest is a complete description of the land. There is no other mention of names, from this point on.]  
"...we have hereunto set our hands and seals this 25th day of December in the year of our Lord Eighteen hundred and thirty five.

Flanders Callaway to John Jones  
1837 Deed

Warren County, Missouri Land Deed Book B, pages 88 and 89.

Transcribed August of 2000 by [James D. Murray](#). I have endeavored to do my best in transcribing the following deed. Please note, as with all transcribed records, mistakes do occur, please refer to original document when in doubt.

Be it remembered that in the twenty first day of August, eighteen hundred and thirty-seven, John Jones presented his petition to the County Court of Warren County in the state of Missouri. Setting for the \_\_\_?\_\_\_ of a hand executed by Flanders Callaway.

To wit: in the first day of May Eighteen hundred and twenty four, said Callaway executed his hand to the said John Jones in the \_\_\_?\_\_\_ sum of one thousand dollars, conditioned that if the above boulder Flanders Callaway does make to the said Jones a quit claim deed to the following described tract of land. To Wit, Two hundred acres of land in the County of Montgomery (now Warren) in the state aforesaid on the waters of Charrett and Tuque Creeks including the farm on which said Jones then lived, being a part of a tract of land \_\_\_?\_\_\_ to the widow St. Franceway & sold by said widow to William Russel and by said Russel to said Flanders Callaway. Which, said tract of land is bounded as follows. To wit, Beginning at the Northwest corner of said survey and thence South 83 degrees East 51 chains and 5 links to corner of said survey. Thence North 7 degrees E. 6 chains and thirty eight links to Joseph Chat(ran?) Northwest corner. Thence S 83 E 14 chains to Morgan Bryans Northwest corner. Thence S 7 West 30 chains 75 links to corner of said Bryans Survey. Thence N. 83 West 10 chains 75 links to another corner of said Survey. Thence S. 7 degrees west six chains and 12 links to corner an a hickory 7 inches in diameter from which a Black oak 18 in diameter bears South 15 E 30 links and a white oak 30 diameter bears North24 West 15 links. Thence North 83 West 54 chains and twenty-five links to corner set post, from which a hickory fourteen inches diameter bears South 84 degrees E 50 links and a beach oak 18 inches diameter bears North 52 West 27 links. Thence North 7 degrees East 30 chains 50 links to the Beginning. That the said Bound to be \_\_\_?\_\_\_. Afterwise to remain in full force and \_\_\_?\_\_\_ and an said petition presented as aforesaid, the said County Court made the following order.

On petition of John Jones the court order that the Administrator of Flanders Callaway Deceased make to said John Jones a deed according to the condition of the Bond in said petition \_\_\_?\_\_\_. Now therefore I, Alexander McKenney, Administrator of said Flanders Callaway, now deceased do by virtue of the authority in me vested as administrator aforesaid have this day bargained and sold and by these presents doth bargain, sell and deliver unto the said John Jones and his heirs and forever all the right, title claim and interest of the said Flanders Callaway of in and to the forgoing described tract of land and do as Administrator aforesaid (aforesaid, scratched through) of said Callaway de (ceased, scratched through and written above ed to form the word deed ) warrant the title of the same against the claim of all persons claiming under the said Flanders Callaway Deceased to the said John Jones and his heirs and assigns forever. In testimony where of I, Alexander McKenney, Administrator as aforesaid and have hereunto set my hand and affixed my seal this the twenty second day of August Eighteen hundred and thirty seven 1837

I underlined before signed, the words petition to the 29th line, and to the (fifth?) line in the second page the words, To the said John Jones and his heirs and of \_\_\_?\_\_\_ forever.

to the estate of his father Flanders Callaway deceased consisting of lands Slaves and personal property agreeable to the last Will and testament of the said Flanders Calloway deceased said Will bearing date the fourteenth day of December eighteen hundred and twentyfour...also all the interest and claim he the said Daniel Boone Callaway has lawfully in the Estate of Jemima Callaway deceased widow of the said Flanders Callaway deceased in the year eighteen hundred and thirty four without a Will the said Flanders Callaway died about the year eighteen hundred and twenty nine.

The Will of Flanders Callaway dated the 14th of Dec 1824, Montgomery Co, Missouri.

The following Will appears in the Warren Co., MO, Deed Book A, pages 190 & 191, after the deed where Daniel Boone Callaway sells land to Alexander McKinnney. Perhaps the Will is listed as documentation of Daniel's right to sell his interest in his father's estate after the death of his mother, Jemima (Boone) Callaway.

I, Flanders Callaway, of the County of Montgomery in the State of Missouri, being weak in body but of sound mind and disposing memory do make and ordain this my last will and testament in t he manner and form following that is do say

First, it is my desire that in a reasonable time after my decease I may be decently interred with unnecessary expense and that as soon after as may be convenient my funeral sermon be preached by the Rev. Lewis Williams, and in case be should fail then by any other respectable preacher of the Baptist faith and order.

Secondly, I desire that all my just debts, Doctors fees and funeral expenses be first-paid.

Thirdly, I give and bequeath to my wife Jemima Calloway the following slaves during her natural life or widowhood in full of her right of dower in slaves that is to say the negro girls Kiskey, Lucinda, Dorcas and Lavina and at the death or marriage of said my said wife the said four above named negro girls and their increase if any to \_\_\_?\_\_\_ to my youngest son Daniel Boone Callaway and his heirs. I also give and secure to my said wife the lawful right of dower in all my personal estate and house hold furniture.

Fourthly, I give to my daughter Sally Barns the wife of James Barnes and his heirs forever one hundred arpents of land to include the improvement on which her husband James Barnes now lives to be laid off in an equitable and convenient form by two or more commissioners to be mutually chosen by my after named executors and the said Sally and James Barns"

Fifthly, all the residue of my lands I give to my son Daniel Boone Callaway and his heirs forever, reserving to my above named wife, Jemima Callaway, her right of dower in the said land during her natural life. I also give to my said son, Daniel B. Callaway and his heirs forever, the following slaves to wit, Bill, Lizza, Squire, Rose and Mary.

Sixthly, I give to my son Larkin S. Callaway and his heirs forever one negro boy named Jeff.

Seventhly, I give to the heirs of John B. Callaway deceased five dollars. To the heirs of James Callaway deceased five dollars. To the heirs of my daughter Tabitha Darst deceased five dollars in full of all rights or demands they the said heirs can have against my said Estate. Also, I give to my daughter Frances Lamme, wife of William T. Lamme, five dollars. To Susanna Howell, wife of Thomas Howell, five dollars. To Elizabeth Bryant, wife of Morgan Bryant, five dollars and to Minerva Jones, wife of John Jones, five dollars as remembrance of the love I bear them, having before given them such portions as I con\_?\_ amounts to their just proportions of my Estate.

Eighthly, I give and bequeath all the residue of my estate of every description both real and personal not above disposed of to my son Daniel Boone Callaway and his heirs forever.

Ninthly and lastly, I hereby constitute and assign my son Larkin S. Callaway and my son in law Morgan Bryant executors of this my last will and testament with full power after my decease to carry the same into full effect as the law directs.

In witnesses whereof I have hereunto affixed my seal and subscribed my name in full evidence of the above as my last will and testament this fourteenth day of December in the year our Lord eighteen hundred and twenty four.

## Veteran Memorials

Boone:

Daniel Boone, Seige of 1788 Indian Wars, Fort Boonesborough, Ky.,- (MO.) June 11, 1800, Delassus, Lieutenant-Governor, appointed him commandant, or sydic, of Femme Osage District, which office he accepted. He retained his command, which included both civil and military duties.

Nathan Boone-Indian war of 1812, commission as captain from President Monroe in March, 1812. August, 1832, he was commissioned captain of dragoons by President Jackson, and during President Polk's administration he was promoted to major of dragoons. In 1850 he was again promoted, and received his commission as lieutenant-colonel of dragoons from President Filmore;

Callaway:

Captain James Callaway Home Militia, War of 1812, 1808-1812-1814 killed by Indians  
Colonel Flanders Callaway officer at Fort Boonesborough, Ky

Heinrich Mische - Johann Heinrich Christoph August Mische - "Henry Mische" served in the Union Army in the Civil War. He was a Private. He was a voluntary infantry in Company C, 49th Missouri Infantry. He served the Union forces from August 31, 1864 through August 2, 1865. He was honorably discharged. Henry died July of 1910 and is buried in Smith Creek UMC cemetery in Warrenton, MO. He was the son of Johann Conrad Mische and Fredericke Dorothea Nolting. He is buried in Smith Creek cemetery. Karen Mische

Lt. Col. Fredrick Morsey, 3rd Mo Cavalry served Warren County in the Civil War. Dorris
